The Government of the Republic of Kenya has received financing from African Development Bank hereinafter called the Bank toward the cost of the East Africa's Centre's of Excellence for Skills and Tertiary Education in Biomedical Science Phase 1, and intends to apply part of the proceeds toward payments under the contracts for Procurement of Hospital Furniture and ICT equipment. For this contract, the Borrower shall process the payments using the Direct Payment disbursement method, as defined in the Bank's Disbursement Guidelines and procedures for Investment Project Financing, except for those payments, which the contract provides to be made through letter of credit.
- 2. Bidders may Bid for one or more Lots as further defined in the bidding document. Bidders wishing to offer discounts in case they are awarded more than one Lots will be allowed to do so, provided those discounts are included in the Letter of Bid.
- 3. The **State Department for Medical Services** now invites sealed Bids from eligible Bidders for supply, delivery, installation, commissioning and testing of hospital furniture and lct Equipment as follows;

- 4. Bidding will be conducted through the National Competitive Bidding (NCB) method as specified in the Bank's <u>Procurement Framework</u> dated August 2015, and is open to all eligible bidders as defined in the Procurement Framework.
