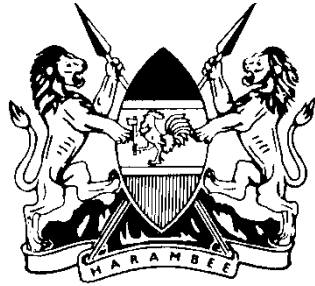

1. This invitation follows the general procurement notice that appeared in UNDB Online reference no. WB4253-784/10 of 28th September 2010
2. The Government of Kenya has received a Credit from the International Development Association toward the cost of Kenya Health Sector Support Project (KHSSP) and intends to apply part of the proceeds of this credit in provision of printing services
3. The Ministry of Health now invites sealed bids from eligible bidders for provision of printing services as below;

4. All bids must be accompanied by a bid security from a financial institution recognized by PPRA. The bid security must be valid for **30 days** beyond the validity of the tender.
5. For Bid no. KE-MOH-15973-NC-RFB, Bidders **MUST** quote for all items, failure to which their bid will be considered non-responsive. The delivery period will be 2-4 weeks from the time the order is placed.
6. Bidding will be conducted through the National Competitive Bidding (NCB) procedures specified in the World Bank's *Guidelines: Procurement under IBRD Loans and IDA Credits*, and are open to all bidders from Eligible Source Countries as defined in the Guidelines.
7. Interested eligible bidders may obtain more information from and inspect the bid document at the Ministry's Supply Chain Management Office situated at the Kenya **Health Sector Support Project Procurement office Prefabricated Block (Adjacent to VIP parking), Afya House Cathedral Road- Nairobi** on normal working days between **9.00 A.M. and 4.00 P.M.**

A complete set of the bidding document may be purchased by interested bidders upon payment of a non-refundable fee of Kenya Shillings one thousand (**Kshs.1, 000/=**) per bidding document in cash or bankers cheque in favour of the Principal Secretary, Ministry of Health at the cash office situated on **2nd Floor Room 218 of Afya House, Cathedral Road-Nairobi** on normal working days between **9.00 a.m. and 4.00 p.m.**
9. Complete bidding documents, enclosed in plain sealed envelopes clearly indicating the **bid description and number** should be deposited in the Tender Box situated at **1st Floor Lift lobby area Afya House, Cathedral Road – Nairobi** or be addressed to:
